### **SITE VISIT AGENDA:**

#### **Application FER17-0003; 14345 Maclay Court (397-03-033); Gaines**

The applicant is requesting a Fence Exception for an 11'-6" tall wall, referred to as a solid fence in the City Code, built in association with a recently constructed new single-family residence. The wall, which is a horizontal extension of the front elevation of the structure, projects into the left side setback area by 9'-10". The City Code limits solid fences, or walls to a height not exceeding six feet. No trees are proposed for removal. The net lot area is 40,040 square feet and the site is zoned R-1-40,000.
