SITE VISIT AGENDA:

Application PDR19-0002, ARB19-0008; 19731 Three Oaks Way (397-18-042); Manisha and Sandeep Jain – The applicant requests Design Review approval to construct a one-story, approximately 20'-6" tall, 4,509 square foot single-family home.
