Recommended Action:

• Marketing tips from Toga Trails:

- Word of mouth marketing worked especially well
- Regular meetings within subcommittees and Laurenhelped groups stay on track
- Put yourself in the perspective of your audience (ie. what incentives or prizes would you want?)

• SED Talks:

- Each speaker brought an interesting array of ideas
- Have more diversity (gender, racial, sexual, neurodiversity, etc.) on the speaker panel next year
- Create contact lists earlier to make sure there's no last minute rush in securing speakers
- Could consider turning initiative into a whole commission effort next year

• Holiday Appreciation cards:

- Don't be afraid to reach out to adults like principals, teachers, councilmembers, firefighters, etc.
- Make sure to always cc Kayla in your emails!
- Dance for Individuals with Disabilities replacement recap:
 - Give more time for marketing
 - Reach out to a wider variety of audiences, not just schools, but different neurodiversity organizations as well
 - Emphasize that events are planned for individuals of all ages and abilities

• Saratoga cookbook event:

• Message friends and people for recipe ideas on social media

• Fundraising tips:

- Create and keep track of a spreadsheet (expenditures, donations, etc.) or anything that keeps the Commission budget organized
- Make sure to come prepared for council and treasurer reports
- Make the initiative clear in order to talk comfortably with others; word of mouth is especially important for fundraising
- Reach out to adults and teens alike

• Saratoga Speaks:

- Don't be scared to follow up and email a lot of people; major struggle was with finding and securing speakers
- Consider keeping in touch with SED Talks to eliminate overlap and share ideas
- Creating and following through with a set schedule makes work more efficient
- General work plan ideas: Think about what you're passionate about and follow through with it! Consider the impacts you want to achieve in the community and work towards it. Don't hesitate to reach out to our staff liaison, Kayla!
- Commissioner words of wisdom:

- The Commission is a safe space: everyone wants to hear any and every idea vou have, so don't be afraid to share!
- Don't be afraid and don't stay quiet if you have an idea; every idea is worthy and make sure to cherish every moment
- Think about events you want to see through and which ones you're passionate about seeing in the Youth Commission
- The skills you learn in the Youth Commission can really benefit the communities you're in; you can only develop these skills by putting yourself fully into the Commission
- Set expectations and deadlines; make sure that you're not taking on too much for you to handle (find your balance)
- Deadlines are a great way to keep yourself accountable
- Having expectations for the people you work with in a subcommittee; get to know the people in your subcommittee
- Don't procrastinate and stay on top of your work; maintain good communication and regular check ins
- o Google Calendar and Google Drive folders are very helpful
- Communicate with subcommittees early and come prepared in your subcommittees
- There is no wrong answer in the Youth Commission
- Observe the people around you and learn from what they're doing: you learn from your own mistakes, but you can also learn from and take away ideas and skills from the work of other Commissioners!
