2.1 **Application PDR18-0003/VAR18-0002; 14362 Springer Avenue (APN 503-26-032); Lands of Bahl.** The applicant requests Design Review approval to construct a new two-story single-family residence with a basement (maximum height 24.6'). The project also includes a variance for a one-car garage when a two-car garage is required. No trees are requested for removal.
