| 2/19 | S3 | Brandish Weapon to Resist Arrest, Vandalism, Suspended DL ARREST | At 6:49 AM, deputies responded to a suspicious person call at a residence in the 18000 block of Greenbrook Court. Upon arrival, deputies attempted to make contact with the suspect, who was suffering from a mental health issue, but the suspect barricaded himself in his vehicle, held a machete to his chest and neck, and used his vehicle to ram and damage patrol vehicles, which were blocking in the suspect vehicle to prevent escape. After some time, deputies de-escalated the situation and arrested the suspect after extricating him from the vehicle, which the suspect drove with a suspended driver's license. The suspect was booked into Main Jail. |
