4/23	S9	Possession of Misappropriated Property, Controlled Substances and Drug Paraphernalia, Under the Influence of a Controlled Substance ARREST	At 6:00 AM, deputies made contact with the occupants of a suspicious vehicle parked on Sobey Road at Spring Brook Lane regarding a traffic code violation. An investigation revealed one of the vehicle's three suspect occupants was under the influence of a controlled substance and in possession of Heroin, Buprenorphine and drug paraphernalia, while another suspect occupant was in possession of misappropriated property and drug paraphernalia, in violation of that suspect's parole terms. The third suspect occupant had outstanding warrants. All three suspects were arrested and booked into Main Jail.

4/24	S5	Non-Injury Hit and Run Collision	Occurred at 3:03 PM at Big Basin Way and Saratoga Sunnyvale Road.
4/25	S8	Non-Injury Collision	Occurred at 1:34 PM at Quito Road and Highway 85.

An investigation revealed the vehicle was stolen from San Luis Obispo and the suspect driver was in possession of a burglary tool, both offenses in violation of the suspect's post release community supervision terms. The suspect was arrested and booked into Main Jail.
4/29	S4	Injury Collision, DUI	At 1:17 AM, deputies responded to a vehicle collision on Highway 9 at Tollgate Road. An investigation revealed the suspect driver was driving under the influence of alcohol. The suspect was medically released and the case will be forwarded to the District Attorney's Office for warrant issuance.
