6/4	S2	Vandalism	Between 10:00 PM on 6/3 and 7:00 AM on 6/4, unknown suspect(s) vandalized four vehicles parked in the driveway of a residence in the 19000 block of Herriman Avenue. The suspect(s) spray painted all four vehicles and keyed or scratched one as well, causing total damages in the amount of approximately \$2,000.
6/4	S2	Petty Theft	Between 5:52 PM and 6:20 PM, unknown suspect(s) took the contents of a mail package on the front porch of a residence in the 20000 block of Glasgow Drive for a total loss of about \$50.
6/5	S3	DUI ARREST	At 1:54 AM, deputies stopped a motorist in the area of Prospect Road and Lawrence Expressway for a traffic violation. An investigation resulted in the arrest of the suspect driver for driving under the influence of alcohol. The suspect was booked into Main Jail.

6/7	S3	Possession of Controlled Substance ARREST	At 3:50 AM, deputies stopped a motorist in the area of Saratoga Avenue and Prospect Road for a traffic violation. An investigation revealed the suspect driver had an outstanding warrant and the suspect passenger was in possession of Methamphetamine. The suspect driver was arrested and booked into Main Jail and the suspect passenger was cited and released.
