7/16	S8	Identity Theft	On 6/21, the victim received information indicating unknown suspect(s) used the victim's personal information to obtain credit with multiple credit card companies. The victim cancelled all the cards and lines of credit before any monetary loss was incurred. The victim lives in Saratoga.	
7/16	S4	Theft by False Pretenses	Between 7/3 and 7/12, the victim contacted unknown suspect(s) regarding an online advertisement for an apartment rental and transferred about \$1,700 to the suspect(s) to secure the rental, at which time the suspect(s) stopped communicating with the victim. The victim lives in Saratoga.	
7/16	S7	Identity Theft	On 7/5, the victim received information indicating unknown suspect(s) used the victim's personal information to open a line of credit and obtain a credit card. The victim cancelled the card and initiated a credit freeze before any monetary loss was incurred. The victim lives in Saratoga.	
7/16	S8	Identity Theft, Theft by Credit Card	On 7/7, the victim received information indicating unknown suspect(s) used the victim's personal and credit card information to open a cellular phone service account for a total loss of about \$454. The victim lives in Saratoga.	
7/16	S1	Identity Theft, Theft by Credit Card	On 7/15, the victim discovered that unknown suspect(s) used the victim's personal and credit card information to make fraudulent purchases for a total loss of about \$1,104. The victim lives in Saratoga.	
7/16	S4	False Personation	On 7/16, the victim received information indicating unknown suspect(s) falsely personated the victim to enter into a contract for the purpose of renting a moving van, which was never returned and ultimately reported stolen. The total loss is unknown. The victim lives in Saratoga.	
7/16	S5	Unlawful Possession of Tear Gas ARREST	At 7:24 PM, deputies responded to disturbance call at Starbucks on Big Basin Way. An investigation revealed the suspect was in possession of an unlawful can of tear gas. The suspect was cited and released.	
7/17	S3	Possession of Stolen Property and Mail, Burglary Tools and Drug Paraphernalia ARREST	At 3:38 AM, deputies responded to suspicious vehicle call in the 12000 block of Candy Lane on report of a vehicle driving down the road and stopping at mailboxes. An investigation revealed the two suspects were in possession of stolen property and mail, in addition to burglary tools and drug paraphernalia. Both suspects were arrested and booked into Main Jail.
